	Steven Gianakis from Greenfields planning, EPSDD provided a presentation on the planning process for new suburbs (greenfield sites). It included the various points in the process where bushfire risks are assessed and appropriate actions considered .				
5.	Western Edge Preliminary bushfire risk assessment – presentation by Eco Logical Australia				
	Nathan Kearns from Eco Logical Australia provided a presentation on the Western Edge Preliminary bushfire risk assessment conducted as part of the planning process outlined previously by EPSDD. Council sought clarification of a number of components of the presentation including the basis for a number of assumptions made and the methodology of the assessment. Several Council members questioned the assessment finding that 95% of the study area, including areas such as Mt Stromlo, were rated as low bushfire risk. 	 possible sources of additional data and modelling approaches. Council requested that it be provided with the methodology used for determination of risk level. EPSDD confirmed that the presentation was based on a finalised report, that it was undertaken internal to government and that public consultation was not expected to occur (subject to government considerations) before the middle of 2022. EPSDD also confirmed that this assessment is just one step in the overall planning process and bushfire risk assessment will continue to be undertaken at further stages in the planning process.

	 David Thornhill from Greenfields, Suburban Land Agency provided a presentation on the process and consideration for bushfire risk mitigation in the final stages of land development. This included a discussion on the development of site specific Bushfire Risk Assessment and Management Plans (BRAMP). Discussion occurred around the processes that were used in these BRAMPs and how the Bushfire Protection Areas are maintained post development. There was some discussion around specific places mentioned in the presentation. SLA agreed to provide more detailed information on those after the meeting.
